

Subject:	Materials Operations Problem Report (MOPR) Form		

This directive provides a Materials Operations Problem Report (MOPR) form that shall be used effectively immediately to report problems in the LTPP materials area, which either require resolution or are intended for informational purposes.

The MOPR form is self explanatory except for the MOPR number. This number consists of two parts as follows:

- A letter code representing the agency submitting the problem report.
 - + F for Federal Highway Administration (FHWA)
 - + NA for North Atlantic RSC
 - + NC for North Central RSC
 - + S for Southern RSC
 - + W for Western RSC
 - + T for Technical Support Services Contractor (TSSC)
 - + L for Laboratory Testing Contractor
 - + O for others.
- A number code representing the MOPR number for the submitting agency, in sequential fashion starting from 01.

For example,


F-07: represents the seventh problem reported by the Federal Highway Administration; and
NA-23: represents the 23rd problem reported by the North Atlantic RSC.

Completed MOPR forms shall be submitted to the FHWA and TSSC materials team leaders, with copies to the LTPP RSC material coordinators.

A complete set of the MOPR submittals and their status will be maintained by the LTPP TSSC, who will post a status report update on their web page on quarterly basis.
